Members of the public who wish to be involved and heard should use venues such as Citizen Forum, Public Hearings, Public Comment Periods, outreach events, seminars, workshops, listening sessions, etc.



Primary Agenda Items

Coordinated Public Transit & Human Services Transportation Plan

Just call it the "Coordinated Plan". The Coordinated Plan concerns many forms of "community transportation" in the region. Community transportation refers to all transportation resources in a community that are available to help meet people's mobility needs. These include both public and private services, such as fixed route buss, shuttles for seniors, taxies, vans that churches or community organizations own and operate, and other services.

This plan needs to be in place for entities like COAST to access federal funds for transportation services for older adults and people with disabilities. There will be a public comment period for the plan starting in late March with a hearing at the April Policy meeting. I'll give a brief introduction to the plan at the meeting. The draft plan is on the SRPC website <u>HERE</u>.

The plan is long as usual. For quick review I recommend focusing on the following sections:

- The demographics executive summary on page 13 and maps starting on page 18
- Check out the wide range of community transportation services starting on page 35
- The findings and recommendations starting on page 74

2024-2025 Unified Planning Work Program development (UPWP)

The UPWP is a comprehensive program of all transportation-related tasks to be completed over the next two years. Strafford MPO is in the process of preparing the next UPWP with NHDOT which will cover state fiscal years 2024 and 2025 (beginning July 1st of calendar year 2023). Staff will be meeting with NHDOT in the next few weeks to discuss draft updates. Staff will provide a summary of the updates and major projects anticipated for that two-year period. Final Ten Year Plan Project Ranking

It's time to make a final decision on the candidate Ten Year Plan projects.

The TAC recommended that the Policy committee approve Scenario 2, which would fund Somersworth's Main St Complete Streets and Lee's improvements to the intersection of NH155/George Bennett/Lee Hook Rd. This remains the top scoring scenario.





1. Introductions

D. Landry convened the Commission portion of the meeting.

2. Public Hearing-Draft Regional Housing Needs Assessment

At 9:09 A.M. D. Landry opened the public hearing at 9:09 A.M.

J. Czysz explained the RHNA is intended to inform the public of the region's housing conditions and the data enclosed is to be used by municipalities in planning a balanced housing stock. In addition to analyzing historical trends, existing conditions, and making projections of future conditions and housing needs, this assessment also identifies tools and techniques that communities can use to further balance housing based on proven successful housing solutions identified within the Northeast and across the nation.

Members engaged in discussion on topics which included the lack of housing for their communities and potential solutions, funding opportunities, where growth should happen, and TIF Districts.

K. Kasper motioned to approve the Regional Housing Needs Assessment. J. Boudreau seconded the motion. A roll call vote was taken.

B. Fisher was excused form the meeting.

5. Review minutes of February 17, 2023

M. Richardson motioned to approve the minutes of February 17, 2023. M. Bobinsky seconded the motion.

6. Discussion Items

a. Community Forum

Community Forum:

M. Towne, Barrington, reported that in the upcoming election in Lee, there is an article on for establishment of TIF district for downtown development. He stated it will bring many pieces in to play.

C. Horton reported that the Somersworth planning board just approved a 128 unit in downtown area. It should spur economic growth downtown.

M. Bobinsky stated that the landlord issue in Somersworth that has been reported in the news is is isolated to one individual. He stated that this is not reflective of the majority of landlords in the city. The city is working on addressing these issues.

J. Czysz provided updates: There are two grant opportunities for municipalities. Both environmental. PREP opened their grant programs focused on water quality programs and the DES just opened their Coastal Program resilience grants. She stated the Commissioners Handbook and Annual report have been printed and are available to take. An introduction for new Commissioners has been rescheduled for next week. NHARPC is working to plan the Commissioner Convening. The theme is what's next in the housing needs.

MB-asked for the status on rt 108 complete streets-status? C. Lents answered that the plan is to have another meeting for public input.

b. Candidate regional CMAQ projects

C. Lentz gave a quick recap on the CEMAC projects. The criteria is the projects have a positive impact on air quality. There are a total of five projects being proposed from our region: one from Dover, one from COAST, one from UNH, and two that are from both UNH and Durham. SRPC no longer needs to rank and vote on these projects, but staff will still conduct air quality improvement analyses for each to demonstrate their benefits for reducing emissions.

c.]Preview of draft Coordinated Transportation Plan

C. Lentz reviewed the draft Coordinated Transportation Plan. There will be a public hearing and public meetings. Colin will provide information in a meeting follow up email.

d. Ten Year Plan Projects-

C. Lentz gave an update on the status of the ten-year plan projects. He explained that Strafford MPO still needs to vote on the final list of candidate projects to be submitted to NHDOT for inclusion in

the draft Ten Year Plan. The deadline for this is April 1st. We should hear from DOT with their feedback of the candidate projects soon. That feedback will determine our final vote on the projects.

C. Lentz noted that the Durham Point Road project is ineligible for this Ten-Year Plan process because it is a local road which is not federal aid eligible. It is eligible for several other funding sources that are upcoming.

The members discussed the need for a group meeting focusing on project development and the funding sources available. Colin will work on scheduling a meeting.
