The meeting was called to order at 9:05am

2. Staff Communications

- C. Lentz noted that SRPC had officially begun working with the consulting firm VHB. He reminded municipalities to contact him with potential projects so that VHB can help develop planning-level scopes and cost estimates.
- J. Czysz said SRPC had convened a resilience sub-committee which will be holding roundtable discussions on the third Thursday of each month at 9:30am. The first roundtable is scheduled for April 15th to discuss local hazard mitigation strategies.

3. Action Items

3.1 Minutes from March 5th 2021

M. Williams made a motion to approve the minutes as written.

Seconded by B. Woodruff.

Vote: A. Talon and L. Dusenberry abstaining, otherwise unanimous in favor (via roll-call vote)

- 3.2 Scoring and Ranking of Transportation Alternatives projects in the Strafford region
- C. Lentz presented the scored ranking for the three projects proposed in the region [full scoring results attached to the minutes]:
 - 1. Dover Pedestrian bridge and trail to complete Community Trail extension.
 - 2. Rochester Filling a sidewalk gap on Portland St.
 - 3. Durham Bicycle and pedestrian improvements on Madbury Rd (paired with utilities).
- C. Lentz explained that this is not the final decision; NHDOT will use this ranking to assign points in their scoring process. He noted that several scorers had remarked that all three projects were excellent and it was difficult to score them.
- S. Pesci asked follow up questions of the project applicants.
- S. Saunders made a motion to approve the TAP scores as presented. Seconded by C. Parker.

Vote: L. Dusenberry abstaining, otherwise unanimous in favor (via roll-call vote)

- 4. **Municipal Roundtable Updates on local COVID-19 adaptation** Are there ways that SRPC can help your community recover from COVID-19?
- S. Saunders said she hears from developers that it's going to be a very busy summer and people have a positive outlook. C. Parker and S. Pesci concurred and said the pandemic has shown that outdoor dining is not only possible, but beneficial. They noted that the temporary outdoor dining areas constructed a year ago were being put back in many places as the weather warms.
- M. Williams said the second COVID-19 wave had impacted the return of ridership, but it is steadily growing again.
- M. Hoffman said he hoped communities were seriously reconsidering policies that restricted outdoor dining and other pedestrian areas in downtowns. He noted that the pandemic may result in "zoom towns" as more people are able to work from home and are not restricted by commute distance.
- S. Pesci said UNH was going to have a ribbon cutting ceremony in May for the Main St TAP project completion. UNH Wildcat transit is holding two public hearings to review changes to their service in the upcoming academic year. S. Pesci said service was being restored following the academic year that was impacted by COVID-19, but it would still be a 20% reduction in service compared to the 2019 academic year. He said UNH was planning to end the Route 5 bus to Newmarket starting in May of 2022. This is primarily due to students moving out of Newmarket to Durham and Dover which has cause Route 5 ridership to decline over five years. S. Pesci recommended that C. Lentz invite Amtrak representatives to a future TAC meeting.
- J. Rand provided an overview of the Promoting Outdoor Play (POP!) project that SRPC staff were just finishing up. He presented a draft of an online map and tool that displayed hundreds of recreation sites around the region. It can be used to sort sites by type: playgrounds, trails, boat launches, etc. J. Rand said the tool would be launching the week of April 19th and there would be an outreach event in the future. N. O'Connor said the goal was to get this tool out to families.
- R. Dewey reminded members that the regional Data Snapshot was still under development and asked them to provide comments on the draft metrics that C. Lentz had sent out recently.

5. Other Business

- S. Kinmond reminded members that he had accepted a position with the town of Alton and thanked everyone for the community discussion and engagement. He said Jon Scruton will be taking over as the Town Administrator for New Durham.
- B. Woodruff said Milton's Town Administrator, Ernest Creveling, would be moving on to a new job and the town was in the process of finding a replacement. He said to contact him in the interim.
- 6. **Citizen's Forum** Citizens of the Strafford region are invited to speak on the subject matter of the meeting. Statements should be limited to three minutes.

No citizens were present to provide input.



Prospective SRPC bicycle improvement projects from statewide Bike/Ped Plan development

The projects below were developed by SRPC staff on a tight timeframe to include improvement projects in the statewide Bicycle & Pedestrian Improvement Plan. Local knowledge and the regional bicycle level-of stress analysis were used to identify potential projects. Emphasis was placed on creating new connections or filling existing gaps between local destinations. There is no guaranteed funding associated with the state Bike/Ped plan.

For the Statewide Bike/Ped Plan, RPCs submitted up to 10 "major" projects and up to 10 "minor" projects. In general, major projects are those that require significant construction of new or expanded facilities; minor projects include shoulder widening or restriping in conjunction with scheduled paving programs. Some major projects were included as "spot improvements" if they were at specific intersections/locations.

SRPC has hired VHB as an on-call consultant who can develop planning level scopes and cost estimates for prospective projects, but we need confirmation from municipalities about the feasibility and interest in projects. Please review the below projects with consideration for funding them through future Transportation Alternatives or Ten Year Plan rounds.
