2) Community Updates

C. Lentz reported that the Portsmouth Planning Board, at a recent meeting, meeting, granted an exception to the parking requirements for second story apartments planned for a building in downtown Portsmouth.

The group engaged in discussion on funding and provided feedback.

M. Williams motioned to approve the TIP Amendments as presented seconded by W. Lehman. Motion passed with all votes in favor.

4) Discussion Items

a. Comments from the MPO's on Statewide Carbon Reduction Program

C. Lentz highlighted the projects in the region and statewide and the comments from NHDOT on the statewide Carbon Reduction Program.

He stated that NHDOT is developing a carbon reduction strategy. MPO's sent NHDOT a letter several stating specific recommendations for how funds could be invested in projects and programs that will reduce carbon emissions in the state.

The group engaged in discussion on ways to reduce carbon emissions including how to reduce idle time with programmed traffic signals.

C. Lentz stated that this is still in development. The question is how best to invest dollars to reduce carbon emissions.

5) Other Business

C. Lentz stated there is late breaking information on the Safe Streets and Roads for All program (SS4A). The four MPOs will be hiring a consultant shortly to begin the process. The consultant will be writing a safety action plan for each of the regions. The main components of each plan will be:

- 1. a political commitment to a quantifiable "vision zero" goal. (hypothetical example: "50% reduction in fatal crashes by 2045")
- 2. a regional list of local projects prioritized for future implementation funding

in order for municipalities to apply for implementation funding in the current round, the plan will need to be written and approved by June 30th 2024. That is an extremely short turnaround time to conduct effective and inclusive outreach, get a comprehensive list of projects, and end with a plan of reasonable quality.

The question is do we try for a hurry-up offense to get it done by June 30th, or take our time and be ready for the next funding deadline in 2025?

There is a lot to do in a short period of time. The only thing the delay hinders is when communities can apply for implementation dollars. The general consensus of MPO's is to take their time.

The consensus of the group was to take the time and do a more thorough job on the plan for the fall.
